TERMS

1. **Fee - \$25.00 per 3' X 8' table. (Indoor) / \$30.00 per 10' x 10' (Outdoor space).** Full payment (cash, check, or money order) is due with registration AND **PHOTO OF CRAFTS (NEW VENDORS ONLY)** postmarked by **September 30, 2010** for table reservation. *[Any cancellations prior to Oct. 10, 2010, will be refunded.] Otherwise the event is considered **NON-REFUNDABLE** unless we cancel the show.*
2. All crafters/vendors are restricted to reserved tables **only**; no indoor crafter.vendor will be permitted to bring in an extra table. Pegboards and Lattice are permitted for placement behind or on crafter's/vendor's reserved table.
3. Sale items shall be limited to **handmade arts & crafts.** These must display the artistic talent of the crafter or crafter's personal associates -no flea market items,

For the 3<sup>rd</sup> year we are **introducing a new section** of our show which will feature

**INDEPENDENT SALES CONSULTANTS**

(ie: "Avon", "Tupperware", "Longaberger", "Pampered Chef, Premier Designs Jewelry etc. )

**Because we will only have 1 available spot for EACH TYPE of "ISC," we can only offer this to the**

**FIRST "ISC" to contact and pay for his/her spot.**

**All "ISC" representatives will be located in a separate area from the individual Crafters. We are hoping that the Independent Sales Consultants will have products from their lines which they can sell at our show, as well as have the opportunity, through our show, to meet new consumers and set up new home shows.**

4. Any crafter wishing to sell a food item, i.e. homemade Holiday Candy, or homemade bread, must have pre-approval from the CRAFT SHOW Committee members. (Call 609-652-1136 for approval).

**We encourage Holiday Candy Makers!!**

**Any food items in conflict with the Fire ladies food stand will not be sold at the CRAFT SHOW.**

5. **Table set up is under the discretion of the committee.** Crafters/Vendors may request electricity, a center or wall space only. The committee and the amount of reserved table spaces will determine placement of crafter's table in the hall.

6. Set up time: 7:30 AM - 8:45 AM.  
Show Time: 9:00 AM - 3:00 PM

**Crafter/Vendor shall keep crafts displayed until at least 2:45 PM.**

Space must be vacated by 4:00 PM.

- Upon arrival, crafter will receive two (2) tickets good for a free hot or cold beverage.

7. PARTICIPANTS AGREE TO TAKE FULL RESPONSIBILITY FOR THEIR MERCHANDISE, DISPLAY, AND PERSONAL TRASH AND AGREE TO RELEASE SPONSOR OF ANY LIABILITY OF SAME

8. NO CRAFTER/VENDOR SHALL SELL HIS/HER TABLE TO ANOTHER CRAFTER/VENDOR

9. SPONSOR reserves the right to deny space to any inappropriate person, not complying with the rules as stated, even in future events.

**10. Any vendor/crafter needing to cancel out of the show at the last minute, must give the Craft Show Chairperson at least 24 hours notice prior to the event!!**

**11. We also encourage each "Independent Sales Consultant" and Crafter to help us by contributing an item to our Raffle Table.**

NOTE: IF THE INDOOR SHOW HAS BEEN SOLD OUT, WE WILL OPEN UP SPACES FOR OUTDOOR VENDORS. (spaces will be open anyway to Vendors with Large Products. THE FOLLOWING RULES WILL BE UPHELD:

**OUTDOOR SPACE RENTAL: \$30.00 (non refundable) 10 x 10**

**VENDOR MUST PROVIDE: Your own covered table, tent, and umbrella**

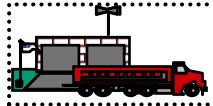
