

RESPECTIVE COUNTIES AND THAT SUCH ELECTIONS SHALL BE CERTIFIED
TO AND CONFIRMED BY THE STATE FIREMEN'S ASSOCIATION.

BE IT FURTHER RESOLVED, THAT A GOPY OF THIS RESOLUTION BE SENT TO WILLIAM EXALL, SECRETARY OF THE STATE FIREMENS ASSOCIATION, FOR THE CONSIDERATION OF THE NEXT MEETING OF THE EXECUTIVE COMMITTEE OF SUCH ASSOCIATION.
