RESOLUTION

Exempt Resolution ---- Atlantic County Firemens Association

Whereas—There is an ever increasing number of Fire Departments being created in the State, many of them in sparely settled sections, wherein the income from their Insurance Premiums can never take care of their beneficiaries or the obligations to them of the State Association.

And Whereas -- Many of the 406 departments of the State are now openly urging the Members who have served seven years to cease to be active and resign, so as to give other members the opportunity to take advantage of the benefits accruing to its Exempt Firemen, and to accumulate rights to the burial benefit granted to the Exempt Fireman by the State Association under the Laws of 1922.

And Whereas--Conditions outlined above are detrimental to the already large body of Exempt Pireman in the State, and militate against the continued possibility of carrying out the liberal provisions to care for all Firemen in a manner already outlined by the State Association.

And Whereas--- Under the equalization feature of the Laws of 1922, the burden of increased Membership, beyond the needs of Local conditions, will fall upon the more thickly populated parts of the State with ever increasing financial exactions as evidenced by the financial reports of 1928 and 1929 until the point is reached where disintegration will be forced if any part of the large number of Relief Associations are to remain solvent and able to take care of thier local needs.

and Whereas—— The Laws creating the period of exemption were passed for Townships in 1890 and the Winston Act in 1891, at which time under the strict interpretations of the Laws of 1895, little relief was granted; No Burial benefits were paid; and no other lure or inducement was offered to become a fireman other than the love of service offered to his fellow—citizen.

Now therefore, let it be Resolved......

That This Atlantic County Firemens Association In Meeting Assembled, At Pleasantville, Atlantic County, N. J. On This The 18th, Day Of February, 1931, For The Above Reasons Given, Recommend and Urge That The Period Of Time Necessary To Make A Fireman Exempt Be Changed From 7 Years, as At Present, To 15 Years, And That The State Executive Committee Be Asked To Concur In This Resolution, And Move To Amend The Law To Make The Change From 7 Years, To 15 Years, Possible.
