The Advisory Committee reported that once again, proposals are being submitted to revise the Blue Light Law. It also looks as if self service gas stations are coming in near future Walt Busby reported that 36 have attended the 4 week course on Fire Investigation and Ara Detection that was given in Galloway Township and that any company desiring to have the class given to contact him.

Walt also reported that he has some sample fire report sheets available to anyone desiring them for their use.

Frank Pratzner reported that he has several sheets for companies in the County Death Benefit. Frank Murphy reported on the Firemen's Home and there are 71 guests at present and also that the museum is 64% completed at present.

Lee Ireland reported on plans and progress to date on the Training Site and Fire Academy and public relations are needed to get the training academy underway and the fire companies are requested to contact their local government and get their backsing and have then in turn contact the County Freeholders.

Enclosed is a copy of letter that Egg Harbor City Fire Dept. forwarded to their Council requesting their support and hopefully all companies will contact their governing bodies for their backing. copy of letter can be used as guide if desired.

The Executive Committee presented the following proposal to establishing procedure for the awarding of the Atlantic County Firefighters' Association Trophy to be given at the annual Firemen's Parade in Wildwood each year.

ELIGIBILITY- Any individual fire company or fire department or municipal owned fire company or fire department, Air National Guard, FAA, N.J. State Forest Fire Service, Atlantic City Fire Reserves, are all included as being eligible for consideration of being awarded the trophy.

Privately owned vehicles are not included as being eligible for the trophy.

ENTRIES- All eligible units, as well as privately owned vehicles, to have the parade application as distributed by the Wildwood Crest Fire Department, in the possession of the Secretary of the Atlantic County Firefighters' Association by the 3rd Wednesday of June of each year. At this meeting, positions of the Atlantic County units will be drawn. The unit that draws lst place will be expected to carry the Banner of the Atlantic County Firefighters' Association and also to provide a three (3) man color guard. The lst place unit will also have the option of their local high school Band to lead the Atlantic County Fkrefighters' group.

However, if the unit in the first place position cannot fulfill the above requirements, the second place unit will lithen have the option of leading the County, and so on down the line In this event, the lst place unit will then step down to the next position and so on. In the event that an application is not received by the Secretary of the Atlantic County Firefighters' Association by the 3rd Wednesday of June, the unit will not be permitted to participate as part of the Atlantic County Firefighters' group, nor be eligible for any consideration for the awarding of the trophy of the Atlantic County Firefighters' Association.

A member of the Pleasantville Co. reported that the City is to revise the role of the volunteers and institute a Fire Reserve and the Secretary was instructed to meet with him and possibly draft a letter as circumstances dictate.

Ernie Day was present and spoke on Bill A-838 wherein the Assembly has passed it and forwarded to the Senate for their approval which has to do with the Lambertville Fire Co. donating a Ahrens Fox truck to the N.J. State Fire Museum in 1961. They tried to regain ownership in 1977, but the courts ruled against them. They are now trying to go thru the backdoor to regain the truck. Funds for the Museum have been approved where it is to be constructed at Allaire State Park. If this truck is returned to them by passage of this bill, there is nothing to stop other fire companies to ask for the return of any of their equipment that is now owned by the state. Then there would be no fire museum at all. This also could affectother museums thruout the State. Ernie strongly requested the Association to vote to the State Senators in Atlantic County and surrounding Counties urging them to vote against this bill.

Motion seconded and carried 29-0 for the Secretary to Send the letters urging repeal of this bill and also requested members to have their companies do likewise.

Bills as presented were approved for payment out of their respectful budgeted accounts.

William Carney reported that Life Members attending the State Convention in Wildwood are entitled to reimbursement of expenses starting with 1984 Convention. Each Relief Assn. is able to pay each life member up to \$93.50 if he attends both sessions and is allowed to pay up to a maximum of \$935.00 for all life members attending. This is a local Association's option wherein they can pay any amount up to the figures stated and if there funds are such that they can't afford to pay, they do not have to.

Charles Guenther, Chief of the Galloway Township Fire Dept., reported that one of their members, James Hanselman of the Germania Co. No. 2, was injured in a farming accident in th fall of 1983 when he was caught in a corn picking machine which resulted in the loss of his left arm as well as the loss of 3 fingers on his right arm and his medical bills are in excess of \$98,000.00 to date. He is also a machinistby trade and cannot perform his job anymore. The Township Fire Dept. is runing a 10 week club benefit in his behalf at \$10 per ticket with 1st drawing to be April 16th and anyone desiring to take part in this benefit may purchase a ticket from anyone of the 5 companies of the Galloway Twp.
