President Portale then pointed out the fire exits and asked that all electronic devices be silenced.

Chief Donnelly of the Collings Lakes Vol. Fire Co. was introduced. Chief Donnelly welcomed all to Collings Lakes and Buena Vista Township.

### In Attendance

Roll call was taken by Secretary Robert A. Mellon who reported a quorum was present.

#### **Approval of Minutes**

**Atlantic County Fire Training Advisory Board** – Chairman Howard Berchtold Jr. reported that the next meeting of the advisory board is 7:00PM on Jul. 9, 2012 at the Anthony "Tony" Canale Training Center. Howard reported that there will be discussion about expanding the training center. Oscar Dutch reported that county government has started to consider expanding the training center.

Fire Coordinator – Ed Vincent reported that he checked with the NJ Division of Fire Safety regarding the SCI air cylinders. The official position is that buying SCI cylinders directly, and not as SCBA manufacturer cylinders, creates a situation where the cylinder does not have the required NIOSH approval since all NIOSH approvals are for SCBA manufacturer labeled equipment as submitted by the SCBA manufacturers. Mike Corbo added that NJ PEOSH will cite any departments using SCI cylinders with their SCBA that are not part of the original manufacturer equipment. Ed reported that the Deputy Fire Coordinator gear will be delivered soon and purchasing a CO meter for the coordinators is being researched. Ed reported that Tender Task Force Div. A (TTF-A) will be having a drill 08:00 July 15 at the Pilgrim Academy, 310 W. Moss Mill Rd., Galloway. Ed reported on attending the ISO Hauled Water Drill held in the Germania section of Galloway Township. The Galloway FD is looking to improve their ISO rating by having an ISO evaluator record the times during the evolutions. The recorded times, along with other data, will be evaluated by ISO and a determination returned at a later date. Ed reported on the status of the Homeland Security Grants. Foam has been ordered. The FY2010 and FY2011 grant proposals are moving forward and include radio equipment. The FY2012 grant has not yet been authorized and rumors have it becoming a regional grant instead of a county grant. Ed reported that the drill scheduled for October 20, 2012 in New Gretna has been postponed until the Spring of 2013 due to adding an EMS component to the overall drill planning. Ed reported that he has not yet heard of any plans for the Atlantic City Air Show scheduled for August 17, 2012. Ed reported that if any municipalities use the county foam stockpile, they will be responsible to replace what was used. Ed reported on a county EOC drill held in May. Ed reported that Longport Fire Dept. will hold their 100<sup>th</sup> anniversary celebration and parade this Friday, June 23, 2012.

**Training** —Director of Training Mike Corbo reported that the Summer FFI is running with fifteen students and the Summer FFII with nine students. The Spring FFI and FFII classes have wrapped up and a graduation ceremony has been scheduled for 19:00 Monday, July 23, 2012 at the Anthony "Tony" Canale Training Center. Mike reported on all upcoming scheduled classes. All classes have room for more students. Please have all firefighters review the class schedule and sign up. Mike will prepare and email the Atlantic County 4H Fair Firefighter Competition rules and application within the next week. A preliminary competition will be scheduled at the training center before the fair. Mike reported on the recent NJ PEOSH regional information seminars. Some news from the seminars includes that NJ PEOSH is requiring that all Firefighters on an active roster by NJ Firefighter I certified. There was no clarity on dedicated Fire Police members requiring Firefighter I certification and NJ PEOSH will review that further for a determination. Secretary Mellon reported on incidents, on a national level, where the US Dept. of Justice was denying the payment of the Public Safety Officers Benefit (PSOB) to beneficiaries of Fire Police that suffered a Line of Duty Death (LODD). The US DOJ determination was that Fire Police are not Firefighters and therefore not entitled to the PSOB. There are currently challenges to that determination but it is still ongoing. Though not a legal opinion, Secretary Mellon recommends that all Fire Police first be certified Firefighters and then assigned Fire Police duty in an attempt to prevent this from being an issue in case of a worst case scenario.

**Library** – Ron Bird reported that he can be contacted if library access is needed.

**Atl. Co. Fire Chief's Association** – Chick Kisby reported that the next meeting of the Atl. Co. Fire Chief's Association will be on July 31, 2012 and is hosted by Estell Manor Vol. Fire Company.

Legislative – John V. Wagner reported that he has reestablished contact with local and regional political representative offices. John reported that they have been asking what the issues are legislatively concerning the shuttering of fire

departments such as Belcoville and Folsom. John reported that he has surveyed several municipalities as to their opinion on the right of the general public to attend fire department meetings. There were three common answers. First, yes if public funds will be discussed. Second, yes if fifty percent or more of financial discussion is public funds. Third, no. On a non fire service note, John reported that the gift card laws can be confusing and have many different regulations that cover store cards or bank issued cards. Please review the disclaimers for what you buy, time limits and fees, and remember it is buyer beware.

**NJ Firemen's Home** – Oscar Dutch reported the paving has been completed and that the boilers will be replaced with new dual fuel models.

**County Radio Communications / Central Dispatch** – Oscar Dutch reported that a county meeting concerning central dispatch will be held on June 21. Vince Jones was to be at tonight's meeting to report on the current status but the Absecon Nursing Home lost air conditioning and he had to work on possible evacuation plans.

**Atlantic County 4H Fair** – Howard Berchtold reported that the fair is scheduled for August 9, 10, and 11. The firefighter competition will be held on August 10. The ACFFA booth will be setup the same as in past years and most handout material has already been obtained.
