June 17, 2015

Call to Order

The regular meeting of the Atlantic County Firefighters' Association was called to order at 20:10 on June 17, 2015 at the Dorothy Volunteer Fire Company by President Amor "Skip" Portale. The meeting was opened with a flag salute followed by an Invocation by the Chaplain of the Association, Reverend Thomas Sweeny. President Portale then pointed out the fire exits and asked that all electronic devices be silenced.

President Portale thanked Chief Robert Gibney and the Dorothy Volunteer Fire Company for offering use of their hall and noted that the association would cover the cost of food ordered for after the meeting. President Portale then introduced Chief Robert Gibney. Chief Gibney welcomed all to Dorothy.

Executive Committee – Chairman Howard Berchtold reported that the next meeting of the executive committee is scheduled for July 3, 2015 in Landisville and updates on the budget and the 501(c)(3) application will be reviewed.

Atlantic County Fire Training Advisory Board – Howard Berchtold reported that next meeting of the advisory board is scheduled for July 6, 2015 at the training center.

Fire Coordinator – Fire Coordinator Ed Vincent reported that there has been no incidents requiring coordinator response and reported on the drills and meetings that were attended. Ed reported that the 177th Air Guard Fire Department Quick

Attack Apparatus should be at the July 15th meeting of this association in Linwood. Ed reminded all of the Triennial Emergency Preparedness Drill scheduled for May 14, 2016 at the Atlantic City Airport. Ed noted that the Atlantic City Air Show is scheduled for September 2nd with practice on September 1st. Ed reported that John Miller has left his position with the county for a position with the state. Tactical Public Safety will assume John's duties with the county radio system. Ed noted that Vince Jones has sent a letter to all fire chiefs clarifying the status of the county radio system and central dispatch plans. Ed reported that he has additional copies of the mutual aid plan on CD if anyone needs them. Ed reported that the current mutual aid agreement expires in July 2015 and that Ed Conover, Atlantic County, will start notifying the municipalities that they need to negotiate and sign a new agreement. The new agreement, once fully executed, will be good for five years until 2020. Ed provided an update to the Homeland Security Grant purchasing plans.

Fire Marshal / Public Relations – Fire Marshal Dave Buzby reported that the valor awards in April was well attended and went well with the exception of the inability to play the year in review video. Dave requested that anyone with a valor nomination for 2016 to please submit as soon as possible after an incident so that it is completed while the memory is fresh instead of waiting until next year. Dave will keep all submissions on file for consideration of a valor award next year.

Training – Director of Training Mike Corbo reported that Firefighter I is running with six students and Firefighter II is running with eleven students. Mike reported that the Firefighter I Graduation Ceremony is scheduled for 7:00 PM, Monday, July 13, 2015 at the Anthony "Tony" Canale Training Center. Mike reviewed that plans for the firefighter competition at the Atlantic County 4H Fair. Applications will be sent out via email soon. A preliminary competition will be scheduled if there is more than four teams entered. A junior firefighter competition will be scheduled if there is interest. Mike noted that he would like to see more teams entered this year and asked all to consider doing so. Mike reported that the Fall 2015 Course Book should be ready prior to the August meeting of the association. Mike reviewed the remaining classes scheduled for this semester.

Atlantic County Fire Chiefs' Association – Chick Kisby reported that the next meeting of the Atlantic County Fire Chiefs' Association will be 8:00 PM on July 8, 2015 at the Estell Manor Volunteer Fire Company.

NJ Firemen's Home – Oscar Dutch reported that the Board of Managers are busy researching a second home to be located in the southern area of the state and possibly being able to handle dementia patients. Available properties are being reviewed. Oscar reported that they have met with state officials and have received much support for the plan.

Atlantic County 4H Fair – Howard Berchtold reported that the fair is scheduled for August 6^{th} , 7^{th} , and 8^{th} with the Firefighter Competition to be held on Friday August 7^{th} . Howard reminded all that assistance will be needed on August 6^{th} to set up and apparatus will again be requested for display for the length of the fair. An apparatus display application will be distributed and only a few hours will be requested of each display piece. Those displaying apparatus may also run a demonstration evolution and it is requested that they note that on the display application.

ACFFA Dinner – Cindy Badger reported that she contacted Mays Landing Country Club and that she was able to reserve Saturday, April 2, 2016 for the 2016 association dinner.
