The memorial service closing prayer was conducted by Chaplain Rev. Thomas Sweeny.

Call to Order

The annual reorganizational meeting of the Atlantic County Firefighters' Association was called to order at 20:25 on January 17, 2018 at the Egg Harbor City Volunteer Fire Department by President Amor "Skip" Portale. The meeting was opened with the flag salute. President Portale then pointed out the fire exits and asked that all electronic devices be silenced.

Opening Remarks

President Amor "Skip" Portale welcomed all to the annual reorganizational meeting and introduced Chief Walter "Butch" Kienzle III of the Egg Harbor City Fire Department. Chief Kienzle welcomed the membership and guests to Egg Harbor City and conveyed the pride felt by this department as it hosts the association for the 95th consecutive meeting and also the 94th reorganizational meeting. Chief Kienzle then introduced the line officers of the fire department.

In Attendance

Roll call was taken by Secretary Robert A. Mellon who reported a quorum was present.

Approval of Minutes

A motion was made, seconded, and carried to approve the minutes of the December 20, 2017 meeting, as sent to the member companies.

Dispensing of Regular Business

A motion was made, seconded, and carried to dispense with the regular business except for the paying of the bills.

Paying of Bills

The bills, totaling \$89.00, were read by Treasurer Jaime C. Mellon. A motion was made, seconded, and carried to pay the bills from the proper funds.

Introduction of Invited Guests

President Portale welcomed and introduced guests; Michael Francis on behalf of Congressman Frank LoBiondo; NJ Assemblyman Vincent Mazzeo; NJ Assemblyman John Armato; Atlantic County Freeholder Chairman Frank D. Formica; Atlantic County Freeholder John W. Risley; and Atl. Co. Fire Marshal: David Buzby.

Michael Francis reported that Congressman Lobiondo was unable to attend due to the congressional schedule. Mr. Francis reported it was an honor to attend the memorial service to honor those that have passed in the last year. Mr. Francis reported that Congressman Lobiondo is fully supportive of the fire service and that an Assistance to Firefighters Grant program seminar has been scheduled at the Anthony "Tony" Canale Training Center for Saturday, January 27, 2018 at 10:00 AM. Mr. Francis reported that he is available to speak with any fire department about any questions or issues and can be reached via the Congressman's Mays Landing office.

NJ Assemblyman Vincent Mazzeo thanked everyone for the invitation to attend the memorial service to honor those that passed last year, noted that he appreciates the effort that the firefighters put forth for their communities, and wished all a Happy New Year.

NJ Assemblyman John Armato reported that that he has started his 48th year serving with the Richland Vol. Fire Company and he truly appreciates the dedication of all firefighters in Atlantic County.

Atlantic County Freeholder Chairman Frank D. Formica reported that he is honored to attend the annual memorial service and noted that the Atlantic County Board of Chosen Freeholders of all the firefighters and first responders serving the county.

Atlantic County Freeholder John W. Risley conveyed his appreciation for the county fire service and the appreciation from the Freeholders that were unable to attend.

Special Presentation and Installation of Officers for 2018

President Amor "Skip" Portale read the following statement.

"Good evening and welcome to the Atlantic County Firefighters' Association's 94th annual re-organization meeting. Since 1924 our re-organization meeting has been hosted by the Egg Harbor City Fire Department, and for that we thank them. Founded in 1923, the primary duty of the Atlantic County Firefighters' Association is to provide training to all firefighters, either paid or volunteer, from Atlantic County. While at the same time offering training to all firefighters throughout New Jersey and the tri state area. This would not be possible without the assistance of Atlantic County Executive Dennis Levinson and his staff, The Board of Chosen Freeholders, Fire Marshall Dave Buzby, Director of Emergency Preparedness Vince Jones, and Director of Fire Training Mike Corbo along with his dedicated staff of 31 Instructors. 2017 was another very productive year for the Association. Some of the accomplishments that were archived in 2017 are as follows. We continue to partner with West Virginia University in the delivery of a first responder training program on alternative fuel vehicles. Our academy continues to offer Pro Board & IFSAC accredited courses that are supported by the NJ Division of Fire Safety. In 2017 we were fortunate enough to get our training academy and instructors featured in the newest edition of the State of New Jersey's Firefighter 1 and 11 course books. In August Jones and Bartlett Publishing Company held a two-day photo shoot at our academy to update the course photos in their new edition. We are continuing our joint venture with the Gloucester County Fire Academy to instruct the Heavy Vehicle Rescue Course held in the spring at our academy and in the fall at theirs. We once again partnered with Kean University to offer the two Fire Instructor Courses required by the New Jersey Division of Fire Safety. In 2017 we initiated a Firefighter Wellness Program to promote the health and fitness of our firefighters that we intend to continue in 2018. We reviewed and updated our constitution and Bylaws. We Trained 1329 Firefighters from Atlantic County. We welcomed 78 new firefighters from Atlantic County into the fire service. This year's classes included firefighters from the Counties of Atlantic, Cape May, Cumberland, Salem, Ocean, Camden, and Gloucester. In 2017 the Firefighters' Association held over 31 different classes with 759 firefighters being trained through academy offered courses and 1,523 firefighters being trained over all. Of that number 194 firefighters were from out of county. The total number of instructor hours incurred by our 31 Fire Instructors for 2017 was 2,832. Once again, as in years past, we were able to operate within our budget. We paid homage to 19 firefighters from Atlantic County who answered their final alarm. We recognized 1 firefighters from Atlantic County with 50 or more years of service. We sponsored the 26th annual Valor Awards Ceremony with 3 firefighters from 2 Atlantic County Fire Departments being honored for their bravery and self-sacrifice. We sponsored the annual Firefighters Competition held in conjunction with the Atlantic County 4H Fair. This year's winning team was from the Somers Point Fire Department Company Sta. 2. We acquired 4 new sets of turn-out gear and additional equipment at no cost to county government, or the taxpayers of Atlantic County, to meet our ever increasing training demands. And last but not least, with the assistance of County Executive Dennis Levinson and the Board of Chosen Freeholders, we were able to have our smoke house completely rehabilitated. As we begin 2018 I look forward to working with Atlantic County Executive Dennis Levinson, the Board of Chosen Freeholders, Fire Marshal Dave Buzby, Director of Emergency Preparedness Vince Jones, the Members of the Executive Committee, and the Director of Fire Training Mike Corbo to keep the Atlantic County Firefighters' Association one of the best in the State."

Executive Committee Chairman Howard Berchtold Jr. thanked all of Atlantic County Government, the association Executive Committee, Director of Fire Training Mike Corbo, and the 31 Fire Instructors for the hard work and continued effort to better the association, and all county firefighters, throughout 2017. Howard reported that the Executive Committee had a reorganizational meeting on January 12th and thanked the committee for believing in him, and Oscar Dutch Jr., enough to keep them on as Chairman and Vice-Chairman for the next year. Howard reported that he looks forward to working with everyone in 2018 and noted that the Executive Committee will be working on getting greater delegate representation at association meetings as well as continuing the program to increase awareness of firefighter health and wellness, which has been proven successful with several good programs in 2017. Howard thanked Charles H. "Chuck" Mackintosh for his service on the Executive Committee and welcomed William L. Merola Jr. for having just been elected to the committee. Howard thanked Cindy L. Badger for serving eight years as the Assistant Secretary-Treasurer and congratulated Sandra L. Walczak who will now serve in that position.

President Portale and Executive Committee Chairman Howard Berchtold Jr. presented a Certificate of Recognition to Charles H. Mackintosh for one year of service with the Executive Committee. During that time Chuck served as the Chairman of the Bylaws Committee and was instrumental in getting the recent updates passed by the end of 2017. Bayview Fire Chief Mark Morton accepted the certificate in Chuck's absence and will see that his family receives it, along with conveying thanks and best wishes from the association, now that Chuck has retired to Florida.

President Amor "Skip" Portale and Executive Committee Chairman Howard Berchtold Jr. presented a Certificate of Recognition, a Proclamation, and a Plaque to Cindy L. Badger for eight years of service as Assistant Secretary-Treasurer. Due to Cindy's absence, the certificate and proclamation will presented to her at the next meeting, or sent to her.

WHEREAS, the Atlantic County Firefighters' Association, with a membership of forty-four fire companies in Atlantic County, New Jersey, is an organization dedicated to public safety; and

WHEREAS, the Atlantic County Firefighters' Association has been serving and representing the fire service within the County of Atlantic since 1923; and

WHEREAS, the Senate and General Assembly of the State of New Jersey enacted an act creating the "Fire Service Resource Emergency Deployment Act" supplementing Title 52 of the Revised Statutes; and

WHEREAS, the "Fire Service Resource Emergency Deployment Act" states that the state fire coordinator shall appoint a county fire coordinator in each county. The state fire coordinator shall appoint the county fire coordinator from the list of eligible candidates submitted by the county emergency management coordinator, in consultation with the fire chiefs of the units of the fire service within each county; and

WHEREAS, the "Fire Service Resource Emergency Deployment Act" states the county fire coordinator shall implement the county's fire mutual aid plan, coordinate the utilization of fire service resources with the county in response to emergency incidents which require implementation of the county's fire mutual aid plan and perform such other duties as may be necessary and appropriate to effectuate the purposes of this act; and

WHEREAS, Edward Vincent was first appointed county fire coordinator and served a two year term in 2004/2005 and was then reappointed six more times through the term for 2016/2017; and

WHEREAS, Edward Vincent announced that he had made the decision to no longer seek reappointment at the end of his term effective December 2017 after having served a total of Fourteen years.
