President Portale reported that Natalie's name will be added to a brass leaf on the Remembrance Tree at the Atlantic County Training Center during the April meeting of this association. The tree honors all of those from Atlantic County fire, police, and EMS that have died in the line of duty. President Portale presented a duplicate of Natalie's leaf to her parents.

The "Striking of the Four Fives" was tolled on the bell by C. Robert Winkler III, "The Lord's Prayer" was sung by the Donna Marie and Howard Berchtold, "Taps" was played by Bugler Joe Ward, followed by the playing of "Amazing Grace" by the Sand Pipers. The memorial service closing prayer was conducted by Chaplain Deacon Richard Maxwell.

### Call to Order

The annual reorganizational meeting of the Atlantic County Firefighters' Association was called to order at 20:25 on January 16, 2019 at the Egg Harbor City Volunteer Fire Department by outgoing President Amor "Skip" Portale. The meeting was opened with the flag salute. President Portale then pointed out the fire exits and asked that all electronic devices be silenced.

### **Opening Remarks**

President Amor "Skip" Portale welcomed all to the annual reorganizational meeting and introduced Chief Walter "Butch" Kienzle III of the Egg Harbor City Fire Department. Chief Kienzle welcomed the membership and guests to Egg Harbor City and conveyed the pride felt by this department as it hosts the association for the 96<sup>th</sup> consecutive meeting and the 95<sup>th</sup> reorganizational meeting. Chief Kienzle then introduced the line officers of the fire department.

A motion was made, seconded, and carried to dispense with the regular business except for the paying of the bills.

### **Paying of Bills**

The bills were read by Treasurer Jaime C. Mellon. A motion was made, seconded, and carried to pay the bills from the proper funds.

### **Introduction of Invited Guests**

President Portale welcomed and introduced guests; NJ Assemblyman Vincent Mazzeo; NJ Assemblyman John Armato; Atlantic County Executive Dennis Levinson; Atlantic County Freeholder Frank D. Formica; Atlantic County Freeholder Richard R. Dase; Atlantic County Freeholder Chairwoman Amy L. Gatto; Atlantic County Freeholder John W. Risley; Atlantic County Surrogate James Curcio; Atlantic County Director of Public Safety Michael A. Fedorko; Atlantic County Sheriff Eric Scheffler; and Atlantic County Director of Fire Training Michael J. Corbo.

Atlantic County Surrogate James Curcio thanked the fire service for keeping traditions, such as this memorial service recognizing the fallen, going.

Atlantic County Freeholder Chairwoman Amy L. Gatto offered condolences to the Dempsey family and expressed her appreciation for the fire service answer the call every day.

Atlantic County Freeholder Frank D. Formica reported that he humbled by the service of the firefighters and offered his deepest sympathy to the Dempsey family.

Atlantic County Freeholder Richard R. Dase thanked all firefighters for protecting the families and homes of Atlantic County.

Atlantic County Director of Public Safety Michael A. Fedorko offered condolences to the Dempsey family and reported that it was an honor attend and recognize all those that passed in 2018.

Atlantic County Director of Fire Training Michael J. Corbo reported that Firefighter Dempsey was in the 2018 Summer Firefighter I class. Director Corbo offered condolences to the Dempsey family on behalf of himself and all the Atlantic County Fire Instructors. Director Corbo reported that Firefighter Natalie Dempsey will be recognized at the Firefighter I Graduation Ceremony on January 28<sup>th</sup> and will posthumously receive her NJ DFS Firefighter I certifications.

Atlantic County Fire Coordinator Levon S. "Lefty" Clayton thanked all the fire service representatives in attendance and offered condolences to the Dempsey family and to all the departments and families that lost someone in 2018.

### Special Presentation and Installation of Officers for 2019

Executive Committee Chairman Howard Berchtold Jr. offered condolences to the Dempsey family and thanked all the elected officials for attending the memorial service. Howard thanked all Atlantic County Government, the association Executive Committee, Director of Fire Training Mike Corbo, and the 31 Fire Instructors for the hard work and continued effort to better the association and the fire academy. Howard noted that Atlantic County has one of the best fire academies in the state, and country, due to the much-appreciated support received from Atlantic County government. Howard offered condolences to

Sam Squire, Cologne Volunteer Fire Company President, on the recent loss of his wife. Howard thanked Dcn. Richard Maxwell for stepping up and answering the call to serve as Chaplain to this association and the Atlantic County fire service after the loss of Rev. Thomas Sweeny. Howard reported that John V. Wagner, past Executive Committee member and past Chief of the Estell Manor Volunteer Fire Company, just passed and services are scheduled for the end of the week. Howard reported that the Executive Committee had a reorganizational meeting on January 4<sup>th</sup> and thanked the committee for believing in him enough to keep reelect him as Chairman for 2019 and electing Levon S. "Lefty" Clayton to as Vice-Chairman now that Oscar Dutch Jr. has stepped down. Howard thanked Oscar Dutch Jr. and R. Thomas Hunter Jr. for their years of service on the Executive Committee before retiring and then thanked President Amor "Skip" Portale for his service as President before retiring. Howard also thanked the Egg Harbor Volunteer Fire Department, and Egg Harbor City, for hosting the annual meeting and memorial service.

President Amor "Skip" Portale read the following statement.

"Good evening and welcome to the Atlantic County Firefighters' Association's 95th annual re-organization meeting. This is the 96<sup>th</sup> consecutive meeting that has been hosted by the Egg Harbor City Fire Department, and for that we thank them. Founded in 1923, the primary duty of the Atlantic County Firefighters' Association is to provide training to all firefighters, either paid or volunteer, from Atlantic County. While at the same time offering training to all firefighters throughout New Jersey and the tri state area. This would not be possible without the assistance of Atlantic County Executive Dennis Levinson and his staff, The Board of Chosen Freeholders, Director of Public Safety Mike Fedorko, Director of Emergency Management Vince Jones, Fire Marshall Dave Buzby, and, last but not least, Director of Fire Training Mike Corbo along with his dedicated staff of 31 Instructors. 2018 was another very productive year for the Association. Some of the accomplishments that were archived in 2018 are as follows. We continue our partnership with West Virginia University in the delivery of a first responder training program on alternative fuel vehicles. Our academy continues to offer Pro Board & IFSAC accredited courses that are supported by the NJ Division of Fire Safety. We're continuing our joint venture with the Gloucester County Fire Academy to instruct the Heavy Vehicle Rescue Course held in the spring at our academy and in the fall at theirs. We once again partnered with Kean University to offer the two Fire Instructor Courses required by the New Jersey Division of Fire Safety. In 2018 we continued our Firefighter Wellness Program to promote the health and wellness of our firefighters that we intend to continue in 2019. We received our charities registration number from the State of New Jersey allowing us to now solicit for donations. Through the outstanding efforts of Fire Marshal Dave Buzby and Director of Fire Training Mike Corbo we were able to have all the fire hydrants at the academy rebuilt at no cost to the county government or the taxpayer. In 2018 1,033 firefighters from Atlantic County were trained in various fireground operations. We welcomed 69 new firefighters from Atlantic County into the fire service. This year's classes once again included firefighters from Atlantic, Camden, Cape May, Cumberland, Gloucester, Ocean, and Salem Counties. In 2018 the Firefighters' Association held over 68 different classes with 625 firefighters being trained through academy offered courses and 1,694 firefighters being trained over all. In 2018 155 firefighters from out of county were trained at our academy. The total number of instructor hours incurred by our 31 Fire Instructors for 2018 was 3,168. Once again, as in years past, we were able to operate within our budget. In 2018 we paid homage to 16 firefighters from 13 Atlantic County fire companies who answered their final alarm. Sadly in 2018 we said goodbye to our Chaplain Tom Sweeny who passed away suddenly on June 12th, 2018. Tom served as our Chaplain for over 25 years having been elected in 19923 and every year thereafter. The bell that was used in tonight's services has been dedicated to tom's memory by the Cardiff Volunteer Fire Company. We recognized 3 firefighters from Atlantic County with 50 or more years of service. We sponsored the 27th annual Valor Awards Ceremony with 3 firefighters from Atlantic County being honored for their bravery and self-sacrifice. Once again, we sponsored the annual Firefighters Competition held in conjunction with the Atlantic County 4H Fair. This year the Somers Point Fire Department Company Sta. 2 won the hose relay and obstacle course events and the Mizpah Volunteer Fire Company won the water rocket event. This year's overall winning team was from Somers Point Fire Department Company Sta. 2. We acquired 6 new sets of turn-out gear and additional equipment at no cost to county government, or the taxpayers of Atlantic County, to meet our ever-increasing training demands. As you begin 2019 with your new President, I'm confident that the relationship that has been established with Atlantic County government, Executive Dennis Levinson, the Board of Chosen Freeholders, Fire Marshal Dave Buzby, Director of Public Safety Mike Fedorko. And Director of Emergency Management Vince Jones, along with the members of the Executive Committee, and the Director of Fire Training Mike Corbo will continue so that the Atlantic County Firefighters Association remains one of the best in the state. At this time, I would like to publicly thank the members of the association for allowing me to serve as your President for the past 11 years. It has been an honor and a privilege to serve you. I'd like to thank county government for all the assistance they have given me and the association over that past 11 years. I would especially like to thank the members of the Executive Committee and Chairman Berchtold for making my job easy. As my wife and I will be relocating to South Carolina later this year please know that I will miss each and every one of you but will cherish the memories of my time as a member of the Atlantic County Firefighters' Association. Thank you."
