



April 17, 2019

Call to Order

The regular meeting of the Atlantic County Firefighters' Association was called to order at 20:00 on April 17, 2019 at the Atlantic County Anthony "Tony" Canale Training Center by President Charles E. "Chick" Kisby III. The meeting was opened with a flag salute followed by an Invocation by the Chaplain of the Association, Deacon Rich Maxwell. President Kisby then pointed out the fire exits and asked that all electronic devices be silenced. President Kisby welcomed all to the meeting which serves as the twenty-eighth annual Valor Awards presentation and the tenth annual recognition of firefighters with fifty or more years of active service.

Opening Remarks and Introduction of Host Chief

President Kisby thanked the Margate City Fire Department for hosting and introduced Chief Daniel Adams. Chief Adams welcomed everyone to the annual valor awards and expressed how proud the Margate City Fire Department is to be hosting the awards for the ninth year. Chief Adams spoke about how providing the best service possible is what the fire service does and while paraphrasing a recent magazine article about handling every call for service as though you have been called to assist your own mother and to always be respectful. Chief Adams thanked all for attending on behalf of the Margate City Fire Department and then ended his remarks with a quote from Chief Edward F. Croker, Chief of Department FDNY 1899-1911. "I have no ambition in this world but one, and that is to be a fireman. The position may, in the eyes of some, appear to be a lowly one; but we who know the work which the fireman has to do believe that his is a noble calling. Our proudest moment is to save lives. Under the impulse of such thoughts, the nobility of the occupation thrills us and stimulates us to deeds of daring, even of supreme sacrifice."

In Attendance

Roll call was taken by Secretary Robert A. Mellon who reported a quorum was present. Total Chief/Delegate Attendance – 57 of 176 Total Member Departments/Companies Represented – 20 of 44

Approval of Minutes

A motion was made, seconded, and carried to approve the minutes of the March 20, 2019 meeting, as sent to the member companies.

Dispensing of Business

A motion was made, seconded, and carried to dispense with the regular business except for the paying of the bills.

Bills

The bills were read by Treasurer Jaime C. Mellon. A motion was made, seconded, and carried to pay the bills from the proper funds.

Introduction of "Harold J. "Whitey" Swartz Valor Awards and Service Recognition"

President Kisby welcomed all to the awards presentation and "50" year service recognitions. President Kisby thanked all valor award recipients for having the courage to do what needed to be done and then also thanked the "50" years of service recipients for having the dedication and commitment for all those years. President Kisby also thanked the valor awards committee for the tough job of reviewing the nominations. President Kisby welcomed and introduced Atlantic County Executive Dennis Levinson. County Executive Levinson stated that he is proud to serve this county with the dedicated firefighters that have the courage to get the job done and thanked all for that dedication and courage. Executive Committee Chairman Howard Berchtold recognized Harold "Whitey" Swartz, for whom the valor awards are now named to honor his memory and dedication to the Atlantic County fire service. Howard also recognized Deacon Rich Maxwell for stepping up to fill the position of Chaplain after the tragic loss of Reverend Thomas Sweeny. Howard thanked those that served on the valor awards committee including co-chairs Billy Merola and Sandy Walczak, Howard spoke about the fire service being a family and how it was an honor to be able to recognize all the award recipients. Howard reminded all that this association and the government of the County of Atlantic worked together to open the Anthony "Tony" Canale Training Center twenty-six years ago. Howard welcomed and introduced guests; Atlantic County Director of Public Safety Michael A. Fedorko, Atlantic County Director of Fire Training Michael J. Corbo, and Atlantic County Freeholder Chairwoman Amy L. Gatto. Freeholder Gatto introduced the other Freeholders that were in attendance; Atlantic County Freeholders: Frank D. Formica, Vice-Chairwoman Maureen Kern, Ashley R. Bennett, Richard R. Dase, and John W. Risley. All invited guests offered words of gratitude for the local fire service and the honored award recipients.

Valor Awards

President Charles E. "Chick" Kisby III and Executive Committee Chairman Howard Berchtold Jr. presented each of the Valor Award recipients with their awards from the Atlantic County Firefighters' Association. This is the twenty-eighth year of the Valor Awards presentation. Recipients have included firefighters, police officers, medical personnel, and civilians. All honorees also received recognitions from NJ Senator Chris Brown, the Atlantic County Board of Chosen Freeholders, and Atlantic County Executive Dennis Levinson.

Assistant Fire Chief Scott Winneberger, Bayview Volunteer Fire Company, highlighted the details surrounding the July 26, 2018 incident that earned recognition for Firefighter (Ret.) Ernie Tarsitano whom had served with the Ventnor City Fire Department.

On July 26, 2018 Firefighter (Ret.) Ernie Tarsitano successfully removed the occupant from a fully involved structure fire on the White Horse Pike in Galloway Township, without the benefit of firefighter protective gear or a water source, just moments before the structure became untenable and a rescue would not have been possible.

Lieutenant Kevin Friel, Hammonton Police Department, highlighted the details surrounding the February 14, 2018 incident that earned recognition for Captain Jim Day, Chief Sean Macri, Firefighter Ryan Finn, Lieutenant Tim Kelly, and Captain AJ Berenato. Lieutenant Friel introduced Firefighter John Warren Jr. who was in attendance.

On February 14, 2018 Captain Day, Chief Macri, Firefighter Finn, and Captain Berenato successfully performed CPR on Firefighter John Warren Jr. after he suffered a myocardial infarction while operating the pump at a structure fire on Union Road in Hammonton. Lieutenant Kelly took over the pump operation and restored water flow to the attack lines in place. Due to the quick thinking and actions of all involved, Firefighter Warren is alive and well today.

"50" Year Service Awards

President Charles E. "Chick" Kisby III and Executive Committee Chairman Howard Berchtold Jr. presented each of the "50" Year Service Award recipients with a uniform bar, gold life member card, and framed certificate from the association. The honorees also received recognitions from NJ Senator Chris Brown, the Atlantic County Board of Chosen Freeholders, and Atlantic County Executive Dennis Levinson.

In addition to honoring those for their service and valor, a ceremony to add a leaf bearing the name of fallen Firefighter Natalie Dempsey to the Tree of Fallen Heroes was held. Firefighter Dempsey, Mizpah Volunteer Fire Company, died in a tragic motor vehicle accident while responding to the firehouse for a reported structure fire on Christmas morning, December 25, 2018. The Tree of Fallen Heroes was installed at the Anthony "Tony" Canale Training Center in 2007 to honor all the Atlantic County first responders (police, fire, and EMS) that have died in the line of duty. Executive Committee Chairman Howard Berchtold Jr. thanked Natalie's parents and family for attending.
