



July 16, 2025

Call to Order

The regular meeting of the Atlantic County Firefighters' Association was called to order at 19:35 on July 16, 2025 at the Linwood Fire Department by President Charles J. Mackintosh. The meeting was opened with a flag salute followed by an Invocation by the Chaplain of the Association, Deacon Rich Maxwell. President Mackintosh then pointed out the fire exits and asked that all electronic devices be silenced.

Introduction of Host Chief

President Mackintosh introduced Chief Martin Walley of the Linwood Fire Department. Chief Walley welcomed everyone Linwood.

In Attendance

Roll call was taken by Secretary Robert A. Mellon who reported a quorum was present.

Total Chief/Delegate Attendance – 39 of 172

Total Member Departments/Companies Represented – 20 of 43

Approval of Minutes

A motion was made, seconded, and carried to approve the minutes of the June 18, 2025 meeting, as sent to the member companies.

Report of Treasurer

A motion was made, seconded, and carried to accept the report of the Treasurer, totaling \$103,123.99, as submitted by Treasurer Jaime C. Mellon and read by Assistant Secretary-Treasurer Clayton E. Tucker.

Special Presentation

Atlantic County Executive Committeewoman Cindy Badger, New Jersey State Firemen's Association (NJSFA), welcomed and introduced NJSFA Vice President Joseph Hankins and 1st Assistant Secretary Brian Martone. Vice President Hankins provided a summary from the NJSFA Advisory Board meeting held on July 10, 2025. The Board approved nine special relief applications totaling \$36,001.12, the year to date is \$306,152.12, and six supplemental applications for \$87,000.00, year to date \$536,939.00. The Board reviewed and approved fifty-five (55) burial claims totaling \$673,030.00. The average age of the deceased firefighters was 76 years old. Twelve of the burial claims were cancer related. Total burial claims YTD are fifty-five (55) and burial claims run July 1st to June 30th. There was a total of eight hundred fifty-nine (859) burial claims for the prior year, paying out \$10,116,833.36. Currently three hundred thirty-two (332) firefighters, or those spouses remaining on the program, are being provided with monthly reimbursement through the Health Care Reimbursement Program and over one thousand (1,000) members have benefited since the program started. There have been forty-one (41) from Atlantic

County who have utilized the Health Care Reimbursement Program with fifteen (15) currently receiving monthly reimbursement.

Committee Reports

Firefighter Health and Wellness - Howard Berchtold spoke of his current battle with advanced mouth and neck cancer and his good recovery outlook due to quick diagnosis and treatment after seeking care for unexplained swelling with no other notable symptoms. Howard thanks the surgical staff of Jefferson Hospital and the Atlanticare cancer treatment center staff for the positive outcome. Howard spoke of the need for all firefighters, and everyone in general, to seek care when signs or symptoms could lead to something bigger if not caught early. Howard spoke of the advancements allowing for much earlier detection of many cancers and highly effective treatments when caught early. Howard noted that his mouth and neck cancer is very likely attributed to the HPV (Human Papillomavirus) virus that everyone has been exposed to at some point. The virus is no more than bad cold or flu like for most people but has a strong probability of causing many cancers at a later point in life. Those cancers include cervix, vagina, and vulva in women; penis in men; anus in both men and women; back of the throat, including the base of the tongue and tonsils (oropharynx), in both men and women. Cancer usually takes years, even decades, to develop after a person gets HPV. There is no way to know who will develop cancer or other health problems from HPV. Howard reported that everyone older that twenty should get regular screenings for those cancers since they have likely already been exposed to HPV and that for the children, or grandchildren, there is a vaccination that should be considered. HPV vaccination can prevent over 90% of cancers caused by HPV, as well as anal, vaginal, cervical, and vulvar pre-cancers (abnormal cells that can lead to cancer). HPV vaccines work best when given at age 11-12 years, before contact with the HPV virus. NJSFA 1st Assistant Secretary Brian Martone reported on the state coverage for career firefighters to receive cancer screenings and his effort to get that coverage extended to volunteer firefighters.

Executive Committee – Chairman Howard Berchtold Jr. reviewed the minutes from the Executive Committee meeting held on July 11, 2025 at the Somers Point Volunteer Fire Company Station 1. The committee learned that Vince Jones will not be attending the July meeting of the association but will be at the August meeting. Both the Atlantic County Firefighters' Association and the Atlantic County Fire Chiefs' Association will recognize Vince for his years of service with the county. The committee was also informed that Fire Photographer Heather Berchtold was involved in a motor vehicle accident, that she is ok, and recovering at home. The committee was informed that the roof operations simulator needs to be replaced, estimated at \$78k, and that the matter will be presented to the County for consideration. The committee discussed the upcoming "The Art of The Company Chauffeur" class and the goal of hosting more one-off seminars if attendance goes well. The upcoming academy training schedule was reviewed, and it was reported that the County is planning to start the instructor gear room rebuild soon. Treasurer Jaime Mellon informed the committee that she will be contacting Suburban Propane due to the costs going up when a set rate should have been locked in. The committee had an extensive discussion about the current insurance policies and brokers noting that more data is needed to advance the discussion and to review the probability of pricing a supplemental policy for the instructors.

Atlantic County Fire Training Advisory Board – Howard Berchtold reported that the next meeting of the Fire Training Advisory Board is scheduled for July 21, 2025 at the Anthony "Tony" Canale Training Center. Howard reported that they will discuss the need to replace the roof operations simulator and seek support from the county for the estimated \$78k cost. Howard noted that letters from the Atlantic County Fire Training Advisory Board, the Atlantic County Firefighters' Association, and the Atlantic County Fire Chiefs' Association seeking county assistance might be something to think about.

Atlantic County Fire Chiefs' Association – Marc Corsiglia reported on the meeting held on July 9, 2025 was well attended and that Lee D'Ottavio, Howell Rescue Systems, was in attendance with his truck and demo tools. The next meeting of the Atlantic County Fire Chiefs' Association is scheduled to be held at 20:00 on Wednesday, August 13, 2025 at the Laureldale Volunteer Fire Company.

Atlantic County Radio Communications –Howard Berchtold reported on a meeting with the County Executive Denny Levinson and that the County awarded an additional \$10,000 contract to ADCOMM for collection of local, regional, and national data related to those potential costs of NG911 and unified CAD/RMS and how much of the cost will be covered by local operations versus state funding and grants. The additional report is expected to be completed by mid-August. The working group will meet again to review that data when the report is received. A meeting with the County Commissioners will be scheduled after review, and they will likely be seeking a unified PSAP instead of continuing with the current eleven PSAPs.

Atlantic County 4H Fair – Howard Berchtold reported that the 4H Fair is scheduled for August 8th and 9th and that ACFFA will setup the public relations tent and seek fire apparatus to be displayed or provided educational demos for the public on Saturday August 9th.

Training – Lefty Clayton reported that the rebuild of the confined space simulator is almost complete and has mostly been handled in-house along with refurbing the storage sheds. Howard Berchtold extended thanks to all the instructors working on those projects.

Fire Coordinator – Fire Coordinator Clyde W. "Chip" Stockton Jr. reported on the nine inches of rain that fell in the East Vineland area of Buena Vista Township on July 10th and on Atlantic City Airshow with practice on July 15th and the show on July 16th lasting only two and a half hours. Chip reported on, and thanked, all the in county, and out of county, support for the airshow. Chip also reported on the recent class about HCT F-500 Encapsulator Agent (new firefighting foam) hosted by Cologne Vol. Fire Company.

NJ State Firemen's Assn. – Executive Committeewoman Cindy Badger reported that the Atlantic County Caucus is scheduled for 7PM on August 12th in Egg Harbor City, registration will start at 6PM. The convention is scheduled for September 12 and 13 in Wildwood. The memorial service followed by the meeting is at 11AM on September 12th with registration from 7AM until 11AM. There will only be registration and voting on September 13th from 7AM until 11AM.

NJ Firemen's Home – Oscar Dutch reported that summer BBQs have been ongoing at the home. There are currently seventy-eight guests in the home and eleven are in preadmission for future openings. Oscar reported that eighteen guests passed in 2024 and they recently held a memorial service. Oscar noted that seven years of service as a firefighter is now required for admission to the home. Oscar thanked the Atlantic County Firefighters' Association for their ongoing support by sponsoring a hole at the home's annual golf tournament. The recent tournament went well and was enjoyed by the one hundred twenty-four that were in attendance. Oscar reported that there has been no update from the home expansion committee and noted that he received his copy of the letter from this association to the home's Board of Managers stating that expansion of the home is not supported. Oscar reported that an Antique Fire Muster is scheduled to be held on September 20, 2025 at the home.

Fundraising – Kim Feinstein reported that he is looking into getting a table setup for the convention in Wildwood to continue selling the association 100^{th} Anniversary merchandise.

There were no communications to report.
